A Farm Member is the principle operator of a farming enterprise which can include a corporate farming entity. Farm members are entitled to:

- Discounted subscription to the MSF Annual Results Compendium, *farmtalk* fact sheets and the Annual Report;
- Professional development programs, forums, social activities, field days and site visits at member rates;
- Access to the 'Members only' section of the website;
- Unlimited Associate memberships.

### FARM ASSOCIATE MEMBERS \$25

Farm Associate Memberships are available for family, close relatives and employees of Farm Members. Farm Associates are entitled to:

- Professional development programs, forums, social activities, field days and site visits at member rates;
- Access to the 'Members only' section of the website;
- Receipt of regular e-news and email.

**Associate Members are *ineligible* to vote or be elected to the Board.**

### INDIVIDUAL MEMBERS \$65

Individual Membership is available to those who support the principles of Mallee Sustainable Farming Inc. Individuals are entitled to:

- Full voting rights;
- Eligibility for election to the Board;
- Receipt of regular e-news and email;
- Discounted subscription to the MSF Annual Results Compendium, *farmtalk* fact sheets and the Annual Report;

### STUDENT MEMBERS \$25
